PROMOTING SUSTAINABILITY AND CAPACITY BUILDING, FEEDING AMERICA RIVERSIDE|SAN BERNARDINO WORKS WITH OVER 300 PARTNER AGENCIES TO PROVIDE HUNGER-RELIEF SERVICES AND EMERGENCY FOOD ASSISTANCE TO NEIGHBORHOODS THROUGHOUT RIVERSIDE AND SAN BERNARDINO COUNTIES. OUR NON-PROFIT PARTNERS ARE HELD TO A STRICT SET OF GUIDELINES AND GOVERNING PROCEDURES THAT ENSURE FOOD IS DISTRIBUTED SAFELY IN ACCORDANCE WITH STATE AND FEDERAL LAW. IN ORDER TO BE ELIGIBLE FOR USDA COMMODITIES, A RECIPIENT OR HOUSEHOLD MUST RESIDE IN THE GEOGRAPHICAL AREA BEING SERVED AND MEET ESTABLISHED INCOME GUIDELINES.
